Notification of Distribution Sources
Pursuant to Rule 19a-1 under the Investment Company Act of 1940

As noted in the table below, Highland Global Allocation Fund (the “Fund”) is making a distribution payable on December 29, 2023, a portion of which is estimated to be in excess of the Fund’s current and accumulated undistributed net income. As of December 29, 2023, the estimated sources of this distribution were as follows:
